

## PRIVACY POLICY

### INTRODUCTION

Welcome to Beyond Doha Hospitality Trading and Services W.L.L. (collectively referred to as "BEYOND Hospitality", "COMPANY", "we", "us" or "our")'s privacy policy.

BEYOND Hospitality has been appointed by the Supreme Committee for Delivery and Legacy ("Supreme Committee") as the official hospitality provider for Qatar Football Festival 2026, including Finalissima Qatar 2026™ Match (the "Tournament"). This policy, as updated from time to time, applies only to personal information (the "Data") processed by or on behalf of BEYOND Hospitality. BEYOND Hospitality, under our agreement with Supreme Committee, collects certain information including, but not limited to, on behalf of Supreme Committee in relation to the hosting of the Tournament and shares the Data with the Supreme Committee UEFA and other authorities (collectively "Tournament Organizers"). In this context, Supreme Committee and BEYOND Hospitality, shall each act as separate, and independent controllers of the Data shared with each other. The respective privacy policies of BEYOND Hospitality and Supreme Committee set out how each entity will use this information. A copy of Supreme Committee privacy policy can be found [here](#).

BEYOND Hospitality respects your privacy and is committed to protecting your personal data. This privacy policy will inform you as to how we look after your personal data (including when you simply visit our website regardless of where you visit it from) and tell you about your privacy rights and how the law protects you.

### 1. IMPORTANT INFORMATION AND WHO WE ARE

#### PURPOSE OF THIS PRIVACY NOTICE

This privacy policy aims to give you information on how BEYOND Hospitality and its group companies collect and process your personal data through your use of this website, including any data you may provide to us (through this website or otherwise) when you sign up to our newsletter, register an account, request a contact or a call back, register your interest in one of our products or services, receive any communications from us, purchase anything or take part in a survey, competition or giveaway.

This website is not intended for children and we do not knowingly collect data relating to children (being a person under the age of 16 for the purpose of this privacy policy).

It is important that you read this privacy policy together with any other privacy policy or fair processing notice we may provide on specific occasions, when we are collecting or processing personal data about you, so that you are fully aware of how and why we are using your data. This privacy notice supplements the other notices and is not intended to override them.

#### CONTROLLER

Unless specified otherwise, BEYOND Hospitality is the data controller and responsible for your personal data that you provide.

Any reference to "BEYOND", "COMPANY", "we", "us" or "our" in this privacy policy shall also refer to the relevant BEYOND Hospitality group company of BEYOND Hospitality Group AG and any affiliated companies under a contract agreement or shared ownership with BEYOND Hospitality Group AG.

You have the right to make a complaint at any time to the supervisory authority for data protection issues in your country of residence. We would, however, appreciate the chance to deal with your concerns before you approach your supervisory authority, so please contact us in the first instance.

BEYOND Hospitality reserves the right to update and change our privacy policy as stated in Section 13 of this privacy policy. It is important that the personal data we hold about you is accurate and current. Please keep us informed if your personal data changes during your relationship with us.

## **2. THE DATA WE COLLECT ABOUT YOU**

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows (please note that depending on your arrangement with us, we may collect some or all of these different kinds of personal data about you):

- **IDENTITY DATA** includes first name, last name, username or similar identifier, title, country of residence, language.
- **CONTACT DATA** includes billing contact, billing address, email address and telephone.
- **FINANCIAL DATA** includes bank account and payment card details. Please note that whilst we may in limited circumstances receive payment card details from you, we do not store payment card details after payment has been made by you and the payment is received by us.
- **TRANSACTION DATA** includes details about payments to and from you and other details of products and services you have purchased from us.
- **TECHNICAL DATA** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this.
- **PROFILE DATA** includes your username and password, purchases or orders made by you, your interests, preferences, feedback, and survey.
- **USAGE DATA** includes information about how you use our website, products and services.
- **MARKETING AND COMMUNICATIONS DATA** includes your preferences in receiving marketing from us and our third parties and your communication preferences.

We also collect, compile, use, and share **AGGREGATED DATA OR PSEUDONYMISED DATA** such as statistical or demographic data for any purpose. Aggregated Data or Pseudonymised Data may be derived from your personal data but is not considered personal data in law as this data does NOT directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data or Pseudonymised Data with your personal data so that it can directly or indirectly identify you, we will treat the combined data as personal data which will only be used in accordance with this privacy policy.

If you require disabled or assisted access to any stadium or have special dietary requirements, you may provide, and we may collect and store **SPECIAL CATEGORIES OF PERSONAL DATA** in the form of any disabilities or health conditions you may have. Apart from this we do not collect any other **SPECIAL CATEGORIES OF PERSONAL DATA** about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data). Nor do we collect any information about criminal convictions and offences.

### **IF YOU FAIL TO PROVIDE PERSONAL DATA**

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with goods or services). In this case, we may have to terminate our contract with you, cancel your order or terminate any services requested. We will notify you if this is the case at the time.

## **3. HOW IS YOUR PERSONAL DATA COLLECTED**

We use different methods to collect data from and about you, including through:

**DIRECT INTERACTIONS.** You may give us your Identity, Contact and Financial Data by filling in forms or by corresponding with us by post, phone, email, support by live chat or otherwise. This includes personal data you provide when you:

- apply for or purchase our products or services;
- create an account on our website;
- subscribe to our service or publications;

- request marketing information to be sent to you;
- enter a competition, giveaway or survey;
- If you chat with us on our live chat service or other equivalent interactive service; or
- give us some feedback or contact us via email or online forms.

Our Agents. You may have had direct interactions and/or placed orders with BEYOND Hospitality's network of Agents. Our Agents, in fulfilling orders placed by you, will provide us with the categories of personal information listed above to carry out the services or complete purchase of products.

Tournament Organizers. You may have had direct interactions, or requested more information about the Tournament through the Tournament Organizers, who then share your personal data with us to carry out your requests including purchase orders and to contact with further information about the Tournament.

**AUTOMATED TECHNOLOGIES OR INTERACTIONS.** As you interact with our website, we may automatically collect Technical Data about your location, equipment, browsing actions and patterns. We collect this personal data by using cookies, server logs and other similar technologies. We may also receive Technical Data about you if you visit other websites employing our cookies. Please see our cookie policy at [beyond-hospitality.com/qatar-football-festival](https://beyond-hospitality.com/qatar-football-festival) for further details.

**TECHNICAL DATA FROM THE FOLLOWING PARTIES:**

**SUPPORT BY LIVE**

If you chat with us on our live chat service, you will be sharing your email address with us for the purposes of sending you a transcript as well as identifying yourself to our support team. This is necessary to provide our service to you. In addition to this information, our live chat system will place a cookie in your browser which will persist until you quit your browser. This is required to ensure that your live chat can continue between separate page requests to our website. We also use records of live chats for staff training, to make sure we can offer you the best possible service.

**4. HOW WE USE YOUR PERSONAL DATA**

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with you.  
Performance of Contract means processing your data and sharing your data with third parties where it is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into such a contract.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.  
Legitimate Interest means the interest of our business in conducting and managing our business to enable us to give you the best service/product and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative) and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you (unless we have your consent or are otherwise required or permitted to by law). - Where we need to comply with a legal or regulatory obligation.  
Comply with a legal or regulatory obligation means processing your personal data where it is necessary for compliance with a legal or regulatory obligation that we are subject to.

Generally, we do not rely on consent as a legal basis for processing your personal data; other than we may in certain circumstances rely on consent as a legal basis for processing your personal data in relation to sending direct marketing communications to you via email (if you consent to them doing so). **PURPOSES FOR WHICH WE WILL USE YOUR PERSONAL DATA**

We have set out above, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

Please note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. **MARKETING**

We strive to provide you with choices regarding certain personal data uses, particularly around marketing and advertising. We have established the following personal data control mechanisms:

**PROMOTIONAL OFFERS FROM US**

We may use your Identity, Contact, Technical, Usage and Profile Data to form a view on what we think you may want or need, or what may be of interest to you. This is how we decide which products, services and offers may be relevant for you (we call this marketing).

You may receive marketing communications from us if you have consented to it or requested information from us or entered into a contract with us where you have agreed to receive future promotional offers from us, or if you provided us with your details when you entered a competition or registered for a promotion and, in each case, you have given us consent and/or authority to receive that marketing. As, explained below, you may stop these promotional offers from us, at any time, by exercising your right to opt-out.

**THIRD-PARTY MARKETING**

We will get your express opt-in consent before we share your personal data with any company outside of BEYOND Hospitality group and affiliated companies for marketing purposes.

**OPTING OUT**

You can ask us or third parties to stop sending you marketing messages at any time by following the optout links on any marketing message sent to you or by contacting us [QFF.Hospitality@beyond-hospitality.com](mailto:QFF.Hospitality@beyond-hospitality.com) at any time or by logging into your account and checking or unchecking relevant boxes to adjust your marketing preferences. Where you opt out of receiving these marketing messages, we may still retain some of your personal data and contact you when necessary in relation to your contract, purchase or other transactions with us.

**COOKIE POLICY**

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of this website may become inaccessible or not function properly. **CHANGE OF PURPOSE**

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

**5. DISCLOSURES OF YOUR PERSONAL DATA**

We may have to share your personal data with the parties set out below for the purposes set out in the table in paragraph 4 above.

- Internal Group Companies and Affiliated Companies. Other companies in the BEYOND Hospitality Group AG - group of companies or affiliated companies under shared ownership and control and carry out services on behalf of BEYOND Hospitality.
- External Third Parties. Including the following: the Supreme Committee, UEFA, Qatar Football Association.
- Service providers acting as processors who provide payment, IT and system administration services, with whom we need to share your information in order to obtain payment from you or to provide the product or service you have requested.
- Professional advisers or investigators acting as processors or joint controllers including lawyers, bankers, auditors and insurers who provide consultancy, banking, legal, insurance and accounting services.
- Law enforcement agencies or local authorities, or security services for the purposes of event security and safety.
- Relevant tax authorities, regulators and other authorities acting as processors or joint controllers who require reporting of processing activities in certain circumstances.
- Tournament Organizers: (including but not limited to Supreme Committee for Delivery & Legacy and associated or group companies).
- Media buying and web agencies including organisations managing or purchasing paid search keywords or display advertising.
- Companies delivering goods or services to you (in cases where we act as an authorised reseller and/or sales agent).
- Service Providers who provide us with communication services such as a live chat or email to the extent that is necessary to carry out the services
- Third parties to whom we may choose to sell, transfer, or merge parts of our business or our assets to. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this privacy policy.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

## **6. INTERNATIONAL TRANSFERS**

We share your personal data within the BEYOND Hospitality group of companies. This may involve transferring your data outside the State of Qatar and/or the European Economic Area (EEA).

Your personal data information may be processed in Switzerland and may be stored and used elsewhere depending on the location of the BEYOND Hospitality group company or service provider who is permitted to access such information under these rules (and such locations may include countries which may not afford the same level of protection of such data as the country from which you provided the information).

Some of our external third parties are based outside the State of Qatar and/or the European Economic Area (EEA) so their processing of your personal data will involve a transfer of data outside the State of Qatar and/or the EEA.

Whenever we transfer your personal data out of the State of Qatar and/or the EEA, we ensure a similar degree of protection is afforded to it by seeking to implement at least one of the following safeguards:

- We will only transfer your personal data to countries that have been deemed to provide an adequate level of protection for personal data.
- Where we use certain service providers, we may use specific contracts approved by the European Commission which give personal data the same protection it has in Europe. For further details, see European Commission: Model contracts for the transfer of personal data to third countries.

## **7. DATA SECURITY**

We have put in place appropriate technical and organizational security measures to prevent your personal data from being accidentally lost, used, or accessed in an unauthorised way, altered, or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions, and they are subject to a duty of confidentiality. However, the Internet is an open system, and we cannot guarantee that unauthorised third parties will never be able to defeat those measures or use your personal information for

improper purposes. We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so. If you communicate with us by email, you should note that the secrecy of Internet email is uncertain. By sending sensitive or confidential email messages or information which are not encrypted you accept the risk of such uncertainty and possible lack of confidentiality over the Internet.

## **8. DATA RETENTION**

### **HOW LONG WILL YOU USE MY PERSONAL DATA FOR?**

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements and/or, where you have provided your consent, future marketing, and other related communications with you.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

By law we have to keep basic information about our customers (including Contact, Identity, Financial and Transaction Data) for up to six years after they cease being customers for tax purposes.

In some circumstances you can ask us to delete your data (please see Request erasure below for further information).

In some circumstances we may anonymise your personal data (so that it can no longer be associated with you) for research or statistical purposes in which case we may use this information indefinitely without further notice to you.

## **9. YOUR LEGAL RIGHTS**

Under certain circumstances, you have rights under data protection laws in relation to your personal data. You have the right to:

- **REQUEST ACCESS** to your personal data (commonly known as a "data subject access request"). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it.
- **REQUEST CORRECTION** of the personal data that we hold about you. This enables you to have any incomplete or inaccurate data we hold about you corrected (though we may need to verify the accuracy of the new data you provide to us). If we provide you with an account, you may review, correct, update or change your personal information at any time by accessing your account on [beyond-hospitality.com/qatar-football-festival](https://beyond-hospitality.com/qatar-football-festival).
- **REQUEST ERASURE** of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have successfully exercised your right to object to processing (see below), where we may have processed your information unlawfully or where we are required to erase your personal data to comply with local law. Note, however, that we may not always be able to comply with your request of erasure for specific legal reasons which will be notified to you, if applicable, at the time of your request.
- **OBJECT TO PROCESSING** of your personal data where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground as you feel it impacts on your fundamental rights and freedoms. You also have the right to object where we are processing your personal data for direct marketing purposes. In some cases, we may demonstrate that we have compelling legitimate grounds to process your information which override your rights and freedoms.
- **REQUEST RESTRICTION OF PROCESSING** of your personal data. This enables you to ask us to suspend the processing of your personal data in the following scenarios: (a) if you want us to establish the data's accuracy; (b) where our use of the data is unlawful but you do not want us to erase it; (c) where you need us to hold the data even if we no longer require it as you need it to establish, exercise or defend legal claims; or (d) you have objected to our use of your data but we need to verify whether we have overriding legitimate grounds to use it.
- **REQUEST THE TRANSFER** of your personal data to you or to a third party. We will provide to you, or a third party you have chosen, your personal data in a structured, commonly used, machine-readable format. Note that this right only applies to automated information which you initially provided consent for us to use or where we used the information to perform a contract with you.
- **WITHDRAW CONSENT AT ANY TIME** where we are relying on consent to process your personal data. However, this will not affect the lawfulness of any processing carried out before you withdraw your consent. If you withdraw your consent, we may not be able to provide certain products or services

to you or fulfil our contractual obligations. We will advise you if this is the case at the time you withdraw your consent.

If you wish to exercise any of the rights set out above, please contact us at [QFF.Hospitality@beyond-hospitality.com](mailto:QFF.Hospitality@beyond-hospitality.com). You will not be discriminated against for exercising any of your rights described in this privacy policy.

#### **NO FEE USUALLY REQUIRED**

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive.

#### **WHAT WE MAY NEED FROM YOU**

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

#### **TIME LIMIT TO RESPOND**

We try to respond to all legitimate requests as soon as reasonably practicable and we will shall endeavor to respond within one month. Occasionally it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

#### **10. AUTOMATED DECISION-MAKING**

Currently, we do not make any decisions based solely on automated processing, including profiling, which produces legal effects (“**Automated Decision-Making**”). In the event our position changes, we will update this privacy policy and inform you as required by applicable data protection laws.

#### **11. THIRD-PARTY LINKS**

This website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy policy or their personal data collection practices. When you leave our website, we encourage you to read the privacy policy of every website you visit and exit the website immediately if you do not agree with the privacy policy. You acknowledge and accept that you are entering these third party websites at your own risk.

#### **12. CHANGES TO THIS POLICY**

From time to time, we will update or modify this privacy policy, in our sole discretion, to reflect changes in legal and regulatory requirements and our business practices. The updated privacy will be posted to this website with a change to the “Last Updated” date (located at the top of this Policy). We encourage you to review this page periodically to stay informed, especially before you provide any personal data. In circumstances where we make updates or modifications to this privacy policy that materially alter your privacy rights, we will provide additional notice, such as via email or with in-service notifications, as required by law. The updated privacy policy will take effect immediately after being posted or as otherwise notified by us. Your continued relationship with us or your continued use of our website, products or services after any such updates take effect will constitute acknowledgement and (as applicable) acceptance of the updated privacy policy

#### **13. QUESTIONS OR SUGGESTIONS**
